**Do not send form with credit card information electronically via email.**

**All deferred payments must be completed within a two (2) year period.** All sponsorship privileges are granted upon full payment of the total sponsorship funds. Deferred Sponsorships that are not paid in full within two years will be considered donations to the aircraft and will not be recognized as completed sponsorships.
